CONSIDERATION OF MINUTES

A motion made by Mr. Norwood, seconded by Mr. Gill to approve the minutes as typed. Motion passed unanimously by voice vote.

NEW BUSINESS

- A. Special Event Beer Permit Triathlon Joe Fleenor. Mrs. Jennifer Noe explained unusual circumstances only allowed non-profit and political organizations to get a permit. They cannot give event permit, may want to discuss after action is taken. Joe Fleenor stated the organization is partnered with the non-profit Cumberland Bi-Centennial Trail. Mrs. Noe suggested amending permit and allowing beer at end of triathlon based on condition of non-profit passing a background check. Mrs. Walker asked if leave ordinance as is or make more broad for special event. Mr. Gill suggested a change to special event permits to allow city to make money. Mrs. Noe agreed with recommendation of board, she will prepare for council an ordinance special event permit, if you want one in Octoberfest. Mr. Jackson asked for Summerfest special event permit. Mrs. Noe suggested limit not on city property, exclusion under Special Event. Mr. Marc Coulon recommended providing security. Mrs. Noe will draft something. A motion made by Gill, seconded by Norwood to withdraw initial request, amend and approve special event beer permit. Vote on motion: Gill-yes, Walker-yes, Norwood-yes, Jackson-yes, Allen-yes, and Mayor-yes.
- B. Walmart Review of Permit for violation and curbside pickup. Mrs. Noe stated the violation was not a beer violation. Ms. Noe was contacted by ABC, about the sale of wine to a minor. Walmart chose to pay the \$1500 fine and fire employee. Mrs. Noe stated legislation changed for wine. There is nothing current because it was not legal until recently. Mrs. Noe called several cities and talked to ABC who stated it is also applicable for liquor stores. A motion made by Norwood, seconded by Walker to approve the ordinance. Vote on motion: Norwood-yes, Gill-yes, Allen-yes, Walker-yes, Jackson-yes, and Mayor-yes.
