

**TOWN OF ASHLAND CITY SPECIAL CALLED COUNCIL MEETING MINUTES**

**CALL TO ORDER** at 6:05 PM by Mayor Allen.

**ROLL CALL**

**PUBLIC FORUM**

**A. Daniel Lee-** Mr. Lee presented two entry proposals. The first proposal would have the entrance off Highway 12 South and second proposal entrance off of Smith Street. Mr. Lee stated these proposals are not seal bids, just a rough estimate including excavation, storm drainage, running electric, water/sewer and road with curb. Furthermore, the only difference in the two proposals is the Highway 12 entrance would need 700 square feet of pavement from the road which would cost \$126,000 more than the Smith Street. Mr. Jackson questioned the number of acres. Mr. Steve Stratton stated approximately five acres. Mr. Lee stated with five acres the city would be able to build a parking lot with 146 parking spots. Mr. Anderson inquired as to why the persistency with the city building there. Mr. Lee stated the land will be developed and the group would like the history and heritage of Cheatham County preserved. Mr. Kerrigan inquired when is the deadline for the foundation to acquire property. Mr. Lee stated one year to start building with park. Mayor Allen stated he would like the city architect to look at the property. Mr. Stratton stated if anyone has any question please feel free to contact Mr. Josh Bell as he drew up the proposals.
