A resolution to adopt the Cheatham County
Hazard Mitigation Plan

WHEREAS, the Town of Ashland City, Ashland City, Tennessee recognizes the threat that natural hazards pose to people and property; and

WHEREAS, undertaking hazard mitigation actions before disasters occur will reduce the potential for harm to people and property and save taxpayer dollars; and

WHEREAS, an adopted Hazard Mitigation Plan is required as a condition of future grant funding for mitigation projects; and

WHEREAS, the Town of Ashland City participated jointly in the planning process with the other local units of government within the County to prepare the Hazard Mitigation Plan;

NOW, THEREFORE, BE IT RESOLVED, that the Town of Ashland City Mayor and Council, hereby adopts the Cheatham County Hazard Mitigation Plan as an official plan; and

BE IT FURTHER RESOLVED, that the Cheatham County Emergency Management Agency will submit on behalf of the participating municipalities, (Ashland City, Kingston Springs, Pegram, and Pleasant View) the adopted Cheatham County Multi-jurisdiction Hazard Mitigation Plan to Federal Emergency Management Agency officials for final review and approval.

A RESOLUTION TO ADOPT THE CHEATHAM
VISION ECONOMIC DEVELOPMENT PLAN

WHEREAS, Cheatham Vision was developed to create a comprehensive economic development plan for Cheatham County, Ashland City, Kingston Springs, Pegram and Pleasant View to meet the needs and challenges of the evolving economic environment and to create opportunities for sustained growth; and

WHEREAS, in order to create an atmosphere of community wide support needed to create a successful economic plan; and

WHEREAS, All communities are interested in protecting our natural resources, quality and way of life; and

WHEREAS, The Joint Economic and Community Development Board, the Cheatham County Chamber of Commerce, and the Cheatham County Commission have all adopted the five initiatives of Cheatham Vision as their economic development platform; and

WHEREAS, The Honorable David McCullough, Mayor of Cheatham County, has asked that all cities pass a resolution in support of Cheatham Vision;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Mayor and Council of Ashland City, Tennessee, meeting in regular session, that:


SECTION 1. The Legislative Body of the Town of Ashland City declares that the city has adopted the three-year Cheatham Vision strategic economic development plan.
