

NOTICE TO CONSULTANT ENGINEERS REGARDING A REQUEST FOR QUALIFICATIONS AND LETTERS OF INTEREST

The Town of Ashland City, an Equal Opportunity, Affirmative Action Employer, seeks to retain the services of a professional consultant engineering firm and a professional management firm to provide services related to construction of federally funded Design and construction of an asphalt trail along N. Main Street beginning at the Cumberland River Bicentennial Trail on Chapmansboro Road to a trailhead at SR-455 Tennessee Waltz Parkway. The project also includes a pedestrian bridge, boardwalk, ADA compliance, a retaining wall and pedestrian amenities. The project shall be accomplished in accordance with TDOT Local Programs guidelines. The professional consultant engineering consulting firm and the professional management firm must be on TDOT's preapproved list or have a completed pre-qualification form filed with TDOT by the deadline for the Letters of Interest. The prequalified firm must have unlimited status. Responsibilities of the professional consultant firm include, but are not limited to:

All letters of interest must be received by The Town of Ashland City on or before 2:00pm, June 5, 2020. The letter of interest and qualifications shall indicate the scope of services to be completed by any sub-consultants.

Phase I Evaluation

The Town of Ashland City will evaluate the top 3 firms on the following criteria (relative



- Workload capacity; including amount of work under contract with the Agency, if applicable (30%)
- Past performance on agency projects (30%)
- Technical approach (e.g., project understanding, innovative concepts or alternatives, quality control procedures (20%)
- Other factors including interviews and demonstrations, as approved by the Agency (10%)
- Any approved non-qualifications-based evaluation criteria (10%)

The consultant evaluation committee holds the ability to conduct interviews based on scoring as Phase II Evaluation.
